I'm writing today as a concerned parent of a John F. Kennedy high school student who plays baseball at the school. Last year, during the COVID-shortened season, the condition of the fields was bordering on dangerous, with: gopher holes; dry patchy grass; and uneven playing surfaces. Understanding that the fields were poorly maintained due to COVID shutdowns and staffing shortages, we parents did what we could to get the field in somewhat playable condition.
