RECOGNITION OF TEEN DATING VIOLENCE AWARENESS AND PREVENTION MONTH, FEBRUARY 2018

WHEREAS, Teen dating violence is a serious and growing problem throughout California; and

WHEREAS, Teen dating violence intervention and prevention programs can help to ensure a positive school climate and safe learning environment for all pupils, address warning signs of dating violence among pupils before behaviors escalate, and prot**acettyhe**fs targeted student**s**nd

WHEREAS, each year, an estimated 1 in 10 Amerideenagers is physically hour a boyfriend or girlfriend;and

WHEREAS, according to the Center for Disease Control and Prevention, Dating Matters: Strategies to Promote Healthy Teen Relationships, 1 in 4 adolescents report verbal, emotional, physical, or sexual dating abuse each **ged**r;

WHEREAS, 43% of LGBTQ teens reported experiencing physical dating violeace;

WHEREAS, 59% of LGBTQ teens reported emotional abuse, compared to 46% of heterosexual youthand

WHEREAS, teen dating violence has been linked to other forms of violence and aggression against peers, including bullying, sexual harassment, sexual violence, and physical violence; and

WHEREAS, victims of teen datingiolence have increased risk for truancy, dropout, teen pregnancy, suicide, having eating disorders, and engaging in other harmful behaviors such as use of alcohol, tobacco, and other drags;

WHEREAS, the establishment of Teen Dating Violence Awareness and Prevention Month will benefit schools, communities, families, and all youth;
