Complaintsallegingdiscrimination, harassmerintimidation and/orbullying must be filed within six (6) months from the date the alleged discrimination, harassment in timidation and/orbullying complaint occurre or the date the complainant irrst obtained knowledge of the facts the alleged discrimination, harassmerint imidation and/orbullying, unless the ime for filing is extended by the superintendent his or her designee Complainants are protected from retaliation.

Complaintswill be investigated and a written decision or reportvill be sent to the omplainant within sixty (60) days from the receipt of the complaint. This sixty (60) day time period may be extended by written agreement of the complainant. SCUSD's person responsible or investigating the complaint shalt onduct and complete investigation in accordance with Title Code of Regulations (T5CCR) sections 46804687 and accordance with ocal procedures adopted under section 4621 (T5CCR).

The District will provide an opportunity for the complainant(s) and/or representatives to present evidence or informatiorRefusal by the complainant to provide the investigator with documents or other evidence related to the allegations in the complaint, or to otherwise fail or refuse to cooperate in the investigation or engage in any other obstruction of the investigation, may result in the dismissal of the complaint because of a lack of evidence to support egations.

If the District refuses to provide the investigator with access to records and/or other information related to the allegation in the complaint, or to otherwise fail or refuse to cooperate in the investigation or engage in any other

requested. If Section 48985 of the Etotherwise applicable, the response, if requested, and report shall be written in English and the primary language in which the complaint was filed.

- A complaint form for a state preschool health and safety issue pursuant to HSC Section 1596.7925 shall specify the location for filing a complaint. A complainant may add as much text to explain the complaint as rise wishes.

- A complainant not satisfied with the resolution of the preschool program administrator or the designee of theistrict superintendent has the right to describe the complaint to the governing board of the local educational agency at a regularly scheduled hearing of the governing board or body, as applicable, of the District.
- A complainant who is not satisfied with the resolution proffered by the preschool program administrator or the designee of the Dict superintendent has the right to file an appeal to the State Superintendent of Public Instruction (SSPI) within 30 days of the date of the report.
- A complainant shall comply with the appeal requirements of 5 **Section** 4632.
- The SSPI or his or her designee shall comply with the requirements of Settlen 4633 and shall provide a written decision to the State Board of Education describing the basis for the complaint, the District's response to the state preschool health and safety issues pursuant to HSC Section 1596.7925 complaint and its remedy or proposed remedy and, as appropriate, a proposed remedy for the issue described in the complaint, if different from the District's remedy.

The District shall report summarized data on the nature essolution of all state preschool health and safety issues complaints pursuant to HSC Section 1596.7925 on a quarterly basis to the county superintendent of schools and the governing boal body, as applicable, of the District The summaries shall be blicly reported on a quarterly basis at a regularly scheduled meeting of the District's governing board. The report shall include the number of complaints by general subject area with the number of resolved and unresolved complaints. Please note United and Complaints and responses are public records.

Information regarding the requirements of this pupil fee lawshall be included in the annual otification distributed to pupils, parentand guardians employees and other interested arties pursuant to Section 4622 of Title 5 of the California Code Regulations.

The District shall establis local policies and procedure so implement the provisions of this law. (cf. Education Code 49011—49013)
